



# INSTRUCTIONS FOR Heparin Caps

### [Scope of Application]

 The product is intended as injection way and injection port for inputting the solution into infusion container. The product is specially designed as a accessory for medical device, which should be used together with infusion set or IV Catheter.

#### [Structure and Properties]

- · It is made up of luer lock connector and rubber seal gasket ;
- The luer lock connector and rubber seal gasket are assembled by automatic equipment hot-pressing;

#### [Usage]

- · Firstly, check valid period and completeness of products before using;
- · Tearing the package at the cut part and take out the heparin cap;
- Connect heparin cap firmly with the conical fitting before wipe the connector of catheter with disinfectant;
- · Wipe the out surface with disinfectant before use it, then do as sterile manipulation requirements;
- Applying certain heparin in indwelling catheter to prevent blood clots formed when the IV Catheter over infusion..

#### [Precautions]

- · It is use must have the specialized nursing staff to carry on;
- · It should be sterile and free from pyrogen before package opened;.
- · It has a valid period of five years, Do not use if it is beyond valid date.
- · Discard after singe use.

## [Warnigs and indications]

- Do not use if the package is opened or damaged, or protective cap is aparted, any part is missed, any foreign matter is found;
- · It should be used by immediately when the package is open.
- The products can not be resued. The repetition use may cause cross infection, even serious illnesses such as hepatitis, HIV and other infectious disease.

#### [Storage]

 Product should be kept in a condition that relative humidity is less than 80%, it also should be free from corrosive gas, cool, dry with good ventilation and clean.
